Niyazi Altintoprak records and processes his own patients' Name, Surname, T.C. ID number, passport number, temporary T.R. identification number, date of birth, marital status, gender, address, telephone number, e-mail address, bank account, IBAN number, credit card information, medical reports, diagnostic examination data, biometric data, laboratory results, test results, doctor analysis and comments , appointment information, prescription information, survey, picture, camera recordings (audio-image), personal data related to IP address.

These personal data are used to process for the purpose of carrying out information security processes, training activities, activities in accordance with the legislation, financial and accounting works, to follow up and execute legal affairs, to carry out communication activities, audit business activities, to ensure business continuity, to purchase goods / services ,to carry out procurement processes, storage and archiving activities, informing authorized persons, institutions and organizations, providing health services, creating and following up appointment records, issuing prescriptions, to carry out activities related to patient satisfaction, providing post-health care support and information, to carry out risk management processes.

The personal data in question are obtained verbally, in writing or electronically, processed fully or partially automatically, and protected by taking all necessary technical and administrative measures in verbal, written or electronic media, in social media applications, information, pictures, camera recordings, information, patient satisfaction transactions, based on the legal reason of "explicitly stipulated in the law, being necessary for the establishment and performance of the contract, fulfillment of the legal obligation" specified in Article 5 of the Law, invoice, payment; social media applications, information, pictures, camera recordings, information, patient satisfaction transactions, where data is processed abroad for appointment based on the legal reason of "obtaining explicit consent".

Private personal data related to health life, for the purpose of protection of public health, preventive medicine, medical diagnosis, treatment and care services, planning and management of health services and financing, without the explicit consent of the data owner by persons or authorized institutions and organizations under the obligation of keeping secrets is transferred if express consent is obtained. In transactions based on explicit consent, data processing is stopped if the explicit consent is withdrawn.

Personal data are shared with real persons or legal entities of private law, suppliers, authorized public institutions and organizations, organizations that we receive contracted services and cooperate with, websites and social media, limited to the realization of the above-mentioned purposes.
